Dr. Ralph Barnhart, dean of the law school, is offering a \$100 reward for information "leading to the arrest and conviction of the person or persons responsible for the wounding of Brown."

Dean Barnhart said that all communications will be kept confidential.

The shooting followed a week of protest against the playing of "Dixie" at University functions specifically pep rallies and football games.

After the Student Senate voted to recommend the discontinuation of the song, Dr. R.A. Worthington, director of the Razorback band, decided to quit playing "Dixie" altogether.

This brought a storm of petitions, signed by approximately 1,300 UofA students protesting the decision. They were presented to the Equity Grievances Committee who also recommended that Dixie be discontinued.
